I understand that pets may participate in activities such as fetching, jumping, playing with toys, and playing with other pets; and said activities involve inherent risk. PetSound Daycare & Boarding PLLC (PS) is not responsible for any accident, injury and/or death of my pet. I hereby waive, release, and hold harmless PS and its successors, assigns, employees and owners from any and all liability, lawsuits, and or claims that should arise from my pet's participation in pet daycare and/or overnight boarding. This release shall apply regardless of the nature and/or cause of said injury.

GOVERNING LAW: This release shall be governed and construed by the laws of North Carolina.

OWNER RESPONSIBILITIES FOR DAYCARE AND BOARDING

As the owner of a pet participating in daycare and/or boarding at PetSound Daycare & Boarding (PS), I agree to abide by the following policies (initial next to each line):

- I agree not to bring my pet into the PS facility if my pet is showing signs of being sick or has fleas. If my pet has fleas I understand my pet may be given a flea bath that I will pay for.
- I agree not to bring my pet into the PS facility if my pet's behavior may jeopardize the safety and health of other pets and/or the PS staff
- I authorize PS to obtain veterinarian care for my pet if needed while participating in daycare or boarding at PS. I agree to pay for said veterinary care for my pet. If time permits, PS will attempt to contact me before obtaining any care.
- I agree to pay all charges for daycare and boarding before picking up my pet. I understand that my pet will not be released until all charges are paid in full.
- I intend to pick up my pet on the specified date. I will notify PS of any changes to the pickup date and assume full responsibility for any additional charges.
- I understand that half-day daycare check out time is 12:00 pm and half-day daycare pets picked up after 12:00 pm will be charged for a full day of daycare. I understand that all daycare pets must be picked up by the end of the business day. If I do not pick up my daycare pet by closing time, my pet will be placed in PS boarding facility and I will be charged for a night of boarding. Additionally, my pet will not be available to pick up until the next business day.
- If I abandon my pet at PS, PS has the right to find a new home for my pet. Abandonment is defined as refusal to provide care for a pet by its owner. Abandonment by North Carolina state law is stipulated when the pet is left unclaimed at the facility for a period of 10 or more days with no contact after written notice to the owners/advisor of the animal to the last known address.
- If I wish to cancel a reservation for daycare or boarding, I must do so more than 24 hours in advance. If I fail to do so, I will be charged accordingly and acknowledge that a booking fee will be put in place. If I fail to cancel more than 24 hours in advance of a holiday booking, I will be charged the entire scheduled daycare or boarding reservation.
